Reports, video/photos will be provided within 10 days of a request by the Client, but may be withheld until payment in full is received.

FEES AND RETAINER

LINDSEY & ASSOCIATES PRIVATE INVESTIGATIONS shall be compensated for all services rendered Client at the hourly rate of \$ 85.00 per hour and \$0.85 per mile. Client agrees to pay the sum of \$ _____ as a retainer fee. **LINDSEY & ASSOCIATES PRIVATE INVESTIGATIONS** will bill hourly against the retainer fee. Client further agrees to pay for any other expenses incurred during the investigation, including, but not limited to hotel bills, videotapes, photos, etc. If travel is anticipated, a fee of \$ 250.00 will be applied toward costs and expenses incurred in the pursuit of this matter. Once any investigative effort is initiated in this case a minimum of 70 % of the retainer will be withheld as Non-Refundable should Client decide to end the investigation after scheduling of staff and/or resources. Any other balance will be refunded to the Client upon request. Client agrees that if payment is tendered via Debit/Credit Card; that Client waives any and all right to "chargeback-refund", regardless of the Financial-credit institution policy or procedure.

COURT APPEARANCES
